Sir Pavo and Dame Ashlinn:

Unto the grand populace of the Adrian Empire, we, HRM Ashlinn Tiernan of Albion and HRM Pavo Rosalia of Umbria, do send greetings.

At this time, we wish to announce our intention to seek the throne of the Adrian Empire. As we are sure that many of you have questions, we have prepared a sampling of some anticipated questions with our answers that should address some of your basic concerns. 1. What specific qualifications make you particularly suited to the position of Crown?

We have both served as members of the Board of Directors, dealing with mundane issues that affect the organization. As Crowns of Albion and Umbria, we have negotiated numerous contracts for site reservations and financial responsibilities. With the aid of HRM Sir William, HRM Ashlinn has created one of the larger subdivision in the Empire, while HRM Pavo has maintained one of the traditionally larger subdivisions in the Empire, with the assistance of HG Dame Rayvn and HRM Marguerita duBois.

HRM Ashlinn Tiernan has been a member of Adria since September 1999 and holds the Knightly ranks of Knight Premier and Knight Master. She also competes on the Knight's Lists in both Combat and Archery. HRM Pavo Rosalia has been a member of Adria since October 1999 and holds the Knightly Ranks of Knight Premier and Knight Bannerette. He also competes on the Knight's List in Archery and Arts.

2. What major contributions have you made since joining Adria? For example, what ministerial positions have you held?

HRM Pavo is currently working on a new database for the Ministry of Rolls and Lists in an effort to centralize recordkeeping for subdivisions.

He has also served as deputy to the Imperial Chancery for two years under HRM William Baine, focusing on judicial matters and interpretation of law, served as a deputy to the Imperial Ministry of Joust and War for six months under HIH Erik the Aweful, volunteered for special Imperial projects for over 5 years, and has served in many judicial matters as Magistrate and Advocate.

HRM Ashlinn has developed the Ministry of Education and established standardized syllabi with emphasis on enhancement of historical and cultural education.

She has also served as Chancellor and Hospitaller for the Kingdom of Aragon, assisted the Office of Physicker at Imperial events, and served as a deputy to the Imperial Chancery.

3. What events have you autocrated? What event proposals and budgets have you generated?

HRM Ashlinn autocrated the National Invitational Steel Tournaments in 2001, 2003, and 2004. She co-autocrated Imperial Banner War West in 2004, in addition to numerous events and demonstrations locally.

HRM Pavo co-autocrated Imperial Banner War West in 2004, and has taught numerous classes on topics such as Estates procedures, combat, heraldry, and the creation of arrows.

4. What are your views on the formation of Shires within the Empire?

We are interested in establishing Shires in untapped areas in addition to providing increased support to existing Shires by utilizing support from nearby subdivisions and creating a regent system.

5. Have you attended an Imperial Estates Meeting? When and where?

HRM Ashlinn has held a vote on the Imperial Estates since November 2001, and has attended all meetings since then. HRM Pavo has attended

Imperial Estates meetings since November 2000, and has held a vote on the Imperial Estates since November 2001. Since that time, he has missed only 3 meetings.

6. Who have you considered for the positions of Imperial ministers?

While we have considered a few specific individuals for Imperial Ministry positions, in the interest of preserving the traditions of the Adrian Empire, while encouraging the fresh vision of newer members, we ask that the populace in general send us their bids and recommendations for all positions so that we can make an informed, comprehensive decision.

7. Do you have your own budget for next year?

With the future needs of Adria being unsure, we would prefer to address this question based on actual expectation rather than anticipation and fear.

8. What are your top three priorities to accomplish next year?

1. Establishing a stable educational environment focusing on internal and external enlightenment as to the historical context of our organization.
2. Establishing a system of unification throughout the Empire while maintaining and protecting the autonomy and individual cultures of the subdivisions within.
3. Encouraging the Chivalry to conduct itself in a manner that is acceptable and established by the Bylaws of the Adrian Empire.

9. What fresh ideas do you have for next year, in addition to making the events more fun?

One of the items we have discussed is how to encourage communication throughout the Empire. One way we will do this is by meeting face to face once per month, more if necessary, to go over all items of concern, so we can make well-rounded decisions together.

We will also be continuing the round table discussions by providing time for them at all Imperial Estates Meetings, and will strive to set aside time at Imperial Events for discussion oriented groups. We will encourage all subdivisions to hold Populace meetings and submit any business

or requests generated by these discussions to the Imperial Body during open discussion.

All correspondence will be answered within 72 hours, even if it is to request additional time to research the problem to provide an accurate response.

Sir Madoc and Dame Kendra:

Thank you for your questions. Having read Sir Pavo and Dame Ashlinn's response we find ourselves in almost total agreement with our worthy opponents statements. We have a few things to add though.

How would you define the positions of Emperor and Empress? What would your job description be?

We are in complete agreement with Sir Pavo and Dame Ashlinn on the definition of the Emperor and Empress. There is very little we can add except to say that the populace and subdivisions can also help define what these positions can be. Should we win the privilege to sit the Thrones of the Empire, we would not only be the heads of the Empire but also fully responsible to it. Look at our response to the "Open Door" policy below for more detail for what we mean.

How would your reign differ from the current reign? (This is not a job, it is an honest question.) What would you do differently, if anything?

Again, we agree with our opponents on the need for better communication. We believe that better communication pertains not only to increased distribution of information, but also the way that ideas and policies are expressed. There should always be a high level of respect, professionalism, courtesy and compassion used when communicating with people at all levels, no matter your personal feelings about the individual or the issue that is being discussed. We realize that better communication is the goal of every crown when they step up. We also know that every crown we

have spoken to has felt overwhelmed with the sheer volume of e-mail and phone calls and issues that they need to attend to. In an effort to realize the goal of better communication and making sure that everyone is heard and all issues are dealt with we plan to appoint a Prime Minister. We believe in delegation. :) A part of the Prime Ministers job would be to help in organizing and prioritizing issues as well as have some authority to act on issues that need high level attention. We are still developing the idea of the Prime Minister and not all duties are yet defined but the ultimate responsibility still lies with the Imperial Crowns. We are eager to hear of any ideas and suggestions people may have. One of the issues we've heard time and time again is that the Imperial crowns get so overloaded with serious unexpected problems that absolutely need their attention that often problems and questions of the smaller Shires and Duchies get prioritized lower on the list and are sometimes never addressed by the only people that really have the authority to help them. It is not that the Imperial Crowns don't care, just that they are so overloaded. We are hoping that distributing some of the burden by creating the Prime Minister position will help to make sure that those pleas never go unanswered! We would also like to expand upon the Crown Manual that Their Imperial Majesties have implemented and help fledgling crowns find their feet faster. We are also open to any ideas that others may have. For instance, the idea of having a monthly Crown Statement of what's going on in the Empire is excellent, hopefully Sir Pavo and Dame Ashlenn won't mind if we borrow the idea and implement it ourselves should we win. We too are dedicated to education and dispensing of information as well as the sharing of tradition and re-learning our own Adrian history. We would like to work with our opponents, no matter who wins, to further these goals.

**What is your stance on how kingdoms are run?
Would you be active in local politics? Or do you
plan on having a hands off stance?**

Terre Neuve is a Kingdom that has always been fiercely protective of our sovereign rights. We believe in allowing Kingdoms to run themselves. There are, of course, extenuating circumstances,

such as when laws (mundane or by-laws) are being broken. We also believe in being aware of what is going on with people. A policy of non-interference does not mean we plan to ignore the Kingdoms. We have plans to visit as many subdivisions as possible on an "Imperial Progress". We also intend to have one of us travel to the East Coast Imperial Crown War and one stay out here on the West Coast. We have always been strong supporters of cross-country interaction. We have met many people, movers and shakers from around the country, at Imperial Estates meetings and Wars. However, there is no better way to get to know a subdivisions culture and people than to experience it yourself, and by knowing these things we can better serve the needs of the people.

Would you have an open door policy toward the populace?

Most definitely! Sir Madoc and I feel that we are very approachable people. I personally believe that a lot of what people want is to be listened to and feel that their concerns have been heard. I don't believe that everyone feels that everyone has to agree with them all of the time, but we should make every effort to at least listen and try to understand the issue...all angles of the issue. I like to hear what everyone has to say, gather as much info as possible, and then come up with a solution (as best I can) that takes into consideration all sides of the problem. We cannot fix problems we are unaware of and we encourage everyone to speak their mind honestly. It takes alot for either of us to be offended. We do not look for the insult in people's words. We feel that we can be objective and Sir Madoc in particular is one of the most pragmatic people you'll ever meet. Above all, we want to know what you, the people, think.

We hope that we have answered your questions and if there are any more please keep them coming!
