VIII. OLD BUSINESS

OB1. Move Imperial Coronation from being the same Weekend as the November IEM. (Vote conducted to separate the events approved by Super Majority)

Separate the Imperial Coronation and Imperial Estates Meetings from being on the same weekend.

Option 1: November IEM will be on the first full weekend of November and will be a Virtual Meeting. Imperial Coronation will be held on the second weekend of November to include additional Imperial Events for the weekend. (Option 1 Approved by voice vote)

Option 2: November IEM will be on the second weekend of November and will be a Virtual Meeting. Imperial Coronation will be on the third weekend of November to include other Imperial Events for the weekend.

Author Commentary: Based on discussions I have split the decision to align the timelines of the November IEM/Coronation the possibility of moving them to different weekends and different events.

Option 1 allows the meeting to occur and not cause issues with chapters holding events or people participating in Halloween activities as they will not need to travel during the holiday. The Imperial Coronation event could be held in conjunction with Tournaments, Collegiums, Discussions, Social Gatherings, and the like to allow us to gather as a community together doing what we love to do versus gathering together to have an Estates Meeting that feels rushed so people can get ready for the Coronation. This would allow us time to have the meeting, but also to have enough time to celebrate the outgoing and incoming crowns.

Option 2 moves Coronation to the 3rd weekend, leaving the 2nd weekend for the Estates Meeting. The only concern voiced for this option was that it does potentially put Coronation the weekend before Thanksgiving which can cause travel issues for people.

Chancellors Note: This does not go into effect until the 2026 Coronation/November IEM

IX. NEW BUSINESS

NB1. Modify Article V – Board of Directors, B – Term of Office of the Corporate Bylaws (vote held to be voted on immediately and passed by voice vote. Approved with no objections)

1. Remove the requirement stating that directors may only succeed themselves once.
2. Change the last sentence to reflect that the Members of the Board are elected in November, and no longer in July.

Regardless of whether a Director's position is for a term of approximately 1 year, 2 years, or some other duration as prescribed by law, the term of a given Director's position shall always begin and end at the regular March Meeting of the Imperial Estates. The term of a given Director position is fixed regardless of whether the actual Director who holds the position is appointed or elected midterm. Directors shall be elected at the same meeting designated for the transfer of the Imperial Crowns (November). ~~Directors may succeed themselves once.~~ A Director may be removed prematurely by action of the Imperial Estates, the action of a duly convened Imperial Court of Justice, or by a unanimous vote of all other Directors (so long as the Board has more than two members). Elections are to take place in November ~~July~~, but the term of office is March to March.⁶

Footnote:

⁶ Members of the BoD are elected in November. The out-going BoD traditionally has a final business meeting the Friday before the regular Budgetary Meeting. That meeting ends with or is followed by the new members of the BoD taking office.

Authors Commentary:

#1:

In July, 2019, OB2 (Standardize the Lengths of BoD Terms of Office) the requirement that directors could succeed themselves only once was removed from law.

In July, 2022, BoD1 (Change the Dates of the Election and Seating of the BoD AND Implement Immediately) inadvertently put that requirement back into law.

The July 2019 change allowed a member to serve as a Director for a maximum of four consecutive years, regardless of whether they held a 2-year term, a 1-year term, or a mix of terms throughout their four years. The verbiage that directors could only succeed themselves once was removed, since member of the Board were now limited to a total of four consecutive years.

The verbiage for the July 2022 change was crafted from older manuals that did not include the new law from July, 2019, which is how the “succeed themselves only once” verbiage found its way back into the law.

#2:

It appears this date was missed in the final version of the new law. Even the footnote was changed with the proper date, even though the body of the text was not.

Sir Puck would like the Estates to discuss the following topic.

Possible Example System:

All Chapters of rank Duchy or above would receive 2 Senior Estates Minor votes. Counties and Marches in a Chapter receive a Major Estate vote. The Crown of the Subdivision has the Chapter vote.

Shires will hold a Chapter Vote and 1 Senior Estates Minor vote. If a Shire has a County or March and has not yet been elevated to Duchy status, those Estates would hold a Major Estate Vote.

The Imperial Crowns will have 1 vote to represent the Members at Large.

DI2. Discuss the potential new Arts Judging process currently being play tested. (Discussion had and feedback received to be reviewed and presented at next meeting.)

DI3. Discuss potentially merging/reworking the manuals. (Discussion had with multiple alternatives presented. TO be reviewed further before presenting as NB.)

To help make things easier for sake of information and to help alleviate the potential for conflicting information, take all of the current manuals and merge them into 2 separate manuals (1 manual is the how to run Adria comprised of the Lex Adria, Bylaws, and Codex Adjudicata and the 2nd manual would be the how to play Adria comprised of the Combat, Archery, Arts, Marshals manuals, etc).

DI4. Discuss and Review membership fees and potential increase (Discussion had. No increase at this time)

With the increase of costs to continue to operate the business side of the Adrian Empire and current memberships bringing in a smaller amount to help offset those costs is it time to look at increasing the yearly membership fees or find other ways to help fund the organization.
