V. REPORTS

A. Executive

1. Crown(s) – Demos and Faires increased in number across the Empire. Member activity increased across the Empire even though number of members in the Empire is fewer than this time last year. Crown has travelled and visited several chapters and regions over the last year and will continue to do such this upcoming year with planned visits to the Northwest, Southeast, Nebraska, Southwest Banner War.
2. President and Board of Directors – BoD is working with the Imperial Crown to get answers from our attorney regarding a couple of items. We have moved to a new insurance company that removes the additional exclusions regarding camping events and/or residential properties.

B. Ministers

1. Archery – No Report
2. Arts and Sciences – Reports need to be sent in from Chapters/ Reports that have been received have shown an increase in Arts activity across the Empire

3. Chancery – Reports and rosters need to be sent in. Chapter Estate Meeting minutes need to be submitted to the Chancellor within 30 days of the Meeting. Rosters need to be submitted by the requested time. If a Chapter does not submit their rosters and the Chancellor’s office is unable to verify estates and non-landed estates for activity prior to the meeting it may require requesting of the Imperial Estates to seat the qualified members.
4. Hospitaler - Greetings, Your Imperial Majesty, Noble Estates, Lords, and Ladies, It has been an excellent year within the Adrian Empire, and a wonderful experience working alongside the many chapters and Crown representatives. All regions have shown remarkable growth, and their online presence continues to be impressive. It is inspiring to see regions collaborating with other groups and engaging in crossover events—this spirit of unity is truly the key to continued growth. Let us also continue to nurture the Arts and our Children’s Tournaments, so that we may share the Dream of our Empire with even more families in the years to come. 5. Joust and War – Wojo and Crown Marshall have only been receiving reports from 3 chapters regularly. Please ensure you are submitting reports. There have been several rules interpretation requests, and 13 test results have been entered this year.
6. Publishing (includes Imperial Webmaster, Chronicler, etc.) – Personal and Mundane issues have delayed work with the website but everything is back on track now. Website design has been completed, and we are now working on getting user database setup for login security and database merged into new website. We are hoping to see the release of the new website soon.
7. Rolls and Lists – Currently having issues with getting paperwork from some chapters but the issues are being resolved and the number of pending events is going down with only about 600+ remaining.
8. Sovereign of Arms – LoRRs have been released and are almost fully caught up now. Clean up project is still under way and hope to have old arms no longer in use released soon.
9. Steward – Mundane issues have caused some delay in activity, a new deputy has been acquired to assist with tasks. Currently approximately 126k in accounts and CDs are

maturing. Steward's laptop crashed and died at the meeting with a new laptop being donated to the Empire so that data can be transferred.

10. Other Officers – Justicar's office – A complaint was filed at IST and a Magistrate has been named and determination of Merit is underway.

VI. CROWN BUSINESS

CRB1. Charter Amendments

Chancery Note: These listings are based on the Membership Summary as of the date of publication. This item was tabled at the July meeting.

A. Consider reducing the following Chapters in status due to insufficient numbers: (Requires majority to approve.)

1. Kingdom of Auroch's Fjord. Current membership 87/100 - Current membership is 88/100. Chancellor Note – Kingdom Charters require a 2/3rd vote to reduce. Chapter not reduced by the will of the Estates.
2. Kingdom of Umbria. Current membership 97/100 – Current Membership 102/100 - Withdrawn
3. Duchy of Thinairia. Current membership 18/20 – Current Membership 18/20 – Chapter not reduced by the will of the Estates

B. Crown announcements regarding Shires

(No approval required. Crowns are providing notification to the Estates.)

By the request of the Vicerine due to her moving from the region and the chapter only having 2 members that are inactive at this time the Shire of Drachetor is hereby dissolved.

C. Requests for change in chartered territory

D. Elevate the following Chapters in status:

1. Duchy of Glynmore. Current membership 79/20 – Current Membership 80/20 – Passed by the will of the Estates with no objections (Glynmore is now to be considered an Archduchy)

E. Change in Chartered lands for the Archduchy of Stirling.

Change the chartered lands of the Archduchy of Stirling to include the mundane counties of Miami-Dade, Monroe and Broward County. Due to a Faire that is

held in Quiet Waters Park (located in Broward County) that is currently attended by both the Archduchy Stirling and the Archduchy of Leicester, which in recent years the faire has been managed by the Archduchy of Leicester, The Archduchy of Stirling request this park either be included in the lands given to Stirling or remain as Imperial land and remain in use for all chapters in the area.
Option A) Southern tip of Florida, inclusive of the mundane counties of Broward, Miami-Dade and Monroe.

OR

Option B) Southern tip of Florida, inclusive of the mundane counties of Broward, Miami-Dade and Monroe, with the exception of Broward County Park known as Quiet Waters Park.

Author's removed Option A – Estates voted to not amend the charter of the Archduchy of Stirling and wished to keep the lands as Imperial Lands so that both Stirling and Leicester are able to use the land with permission from the Imperial Crown.

Motion Failed with the Aye's conceding by verbal acclamation

Authors Commentary:

Greetings to The Imperial Estates,

To promote the continued growth of the ArchDuchy of Stirling, as well as the Empire of Adria, the Estates of Stirling request consideration of a land grant of certain Imperial Lands in the State of Florida.

We request the remainder of lands in Broward County Florida which are currently held by the Empire. These lands were formerly held by the Chapter of Pembroke which was dissolved under the reign of this Gabriele and L'Bet'e in 2016. These requested lands include a park that is currently Imperial Land where a large Renaissance Festival is held yearly. For many years in the past, Adria had an encampment at this festival. Due to some misbehavior, the Empire was asked to not return. We did return for many years as the History of Chivalry. In 2024, Leicester contacted the festival owner to hold an Adrian Empire demo. This festival/demo is attended by both of the local Adrian chapters. It should benefit all chapters in the area for membership. We request that the lands of the mundane Broward County Park known as Quiet Waters Park, either be made shared lands between Leicester and Stirling, or be maintained as Imperial Lands.

This would create a new geographical charter to read either

Option A) Southern tip of Florida, inclusive of the mundane counties of Broward, Miami-Dade and Monroe,

OR

Option B) Southern tip of Florida, inclusive of the mundane counties of Broward, Miami-Dade and Monroe, with the exception of Broward County Park known as Quiet Waters Park.

VIII. OLD BUSINESS

OB1. Allow the use of Synthetic Spears in Waster Combat.

The use of synthetic spears in Waster Combat was play tested from 11/2022 through 5/2025. Play test paperwork was submitted on 11/2022. Reports were filed until 08/24, with a final follow-up report on 5/25.

Synthetic Polearms

- a. It consists of a length of PVC or wood that is relatively non-flexible and attached to a synthetic weapon.
- b. A wooden dowel may be inserted into flexible PVC to stiffen it.

- c. The synthetic weapon must be attached such that there is no danger of it slipping off of the pole during combat.
- d. Variations to synthetic pole weapons must be approved by the Crown Marshal, Minister of Joust and War, or a higher officer before their first use.
- e. Seven-foot maximum length.

Cross-Guards

- a. Shall protrude no more than 10 inches from either side of the handle.
- b. Shall be rounded or padded such that they are no smaller than the end of a synthetic weapon.
- c. The synthetic pole arm can be used for thrusting, chopping, and slicing.

Authors commentary: Pole weapons are well documented within the period used by the Adrian Empire.

A simple pole extension can be used with disguised PVC over wood, so a synthetic weapon can fit into it. The Pole extension should be wood with a PVC sleeve at the end so the synthetic weapon can fit into it. Different designs and makers of synthetic weapons can be fitted by adding a simple wooden insert into the PVC that firmly holds the synthetic weapon in place.

We have been testing synthetic spears for 2 years now. They have been popular. The synthetic spear is safer than a synthetic weapon on its own. Synthetic weapons have a tendency to break at the plastic pommel shearing off at the bolt. The synthetic spear uses a pole arm extension that the synthetic weapon slides into. Having the additional material around the hilt, we have not had a single pommel break even after 2 years of hard use. They were tested at Adrian, HEMA, and cross-group practices, undergoing extreme testing in 119-degree desert heat and freezing weather. The added pole arm shaft helps the angle of the blade to flex properly in a thrust as well. Thrusting is comfortable and allows a more historical style to be used in combat. The synthetic spear can be used for thrusting, chopping, and slicing.

We found similar rules to current Adrian shinai pole arms to be safe when using synthetic pole arms, meaning no pole weapon over 7 feet in length and no cross guards over 10 inches.

4. Meeting Date, March

The Imperial Estates shall meet in March of every year, at which time they shall conduct appropriate business including but not limited to:

- a. Evaluation of the success or failure of the previous Imperial Crown's term of office as well as any prior terms of office not yet evaluated, irrespective of the length of such terms of office. (The Imperial Estates shall have the right to table consideration of any Imperial term of office.)
- b. Elect standing members to the special panel defined in Bylaws of the Adrian Empire, Inc., Article III.A.4.b

5. Meeting Date, July

The Imperial Estates shall meet in July of every year, at which time they shall conduct appropriate business including but not limited to:

- a. Qualify and determine acceptability of Imperial candidates
- b. Finalize enough data to prepare the corporation's tax returns (if necessary)
- c. Review (at its discretion) any systems of conversion for analogous activates developed by the Imperial Crown (see Article IX.E.)

Each Chapter's Crown shall present a copy of his or her Chapter's financial records and chattel list at this meeting. Attendance at this meeting shall be mandatory for at least one ruling Crown or representative from each Chapter.

Authors Commentary: This is to align the IEM meeting calendar with the current practice and changes to Board of Directors elections and fulfillments. One of the main things this does is allow the BoD to have and maintain their own budget to handle the costs of doing business without having to go through the Imperial Crown for expenditures

OB3. Change Bylaws Article V. Board of Directors

A. Number of Directors

The number of Directors shall be nine. Two shall be at-large Directors, who shall be elected annually by the Imperial Estates from the membership at large for 1-year terms. ~~The Imperial Steward shall serve as Treasurer and may serve successive terms (as this is an appointed position)~~

~~by the Imperial Crown~~). One shall be the Treasurer who shall be elected to serve a two-year term.

The Imperial Estates will elect the remaining six Directors of the Board of Directors from among the paid membership by a simple majority vote; those elected shall serve two-year terms and shall be termed “regional Directors.” Two regional Directors shall be elected from each region (1, 2, and 3) as defined in Imperial Estates Writ 21.a. One 2-year-term Director shall be elected each year from each region, thus staggering the election of the six 2-year-term Directors.

F. Responsibilities of the Board of Directors

The Officers of the Corporation are the President, Vice-President, and Secretary-Treasurer (~~Imperial Steward~~). The Chief Executive Officer shall be as designated in the Lex Adria Imperium.

Authors Commentary: Moving the Imperial Steward out of the BoD and making the treasurer an elected position ensures the Imperial Estates have a say in who is taking care of financial matters for the corporation. The Treasurer would then have the same limits that other BoD directors have and could serve as a proper financial expert to oversee expenditures made by the Imperial Steward and Chapters and be able to report matters to the Board and also be the one responsible for paying for the costs of doing business, I.E. lawyer fees, accounting, insurance, registrations without having to go through the Imperial Crown to expend the funds needed for such.

OB4. Update IEW #1 & #37 Manual of Arts & Sciences

Replace II. Scoring and Appendix D. Forms 3. Judging Forms and 7. Arts and Science Judging Form and Guide Version 9 (Adrian Empire IEW #1 Standard Judging Form Guideline and Criteria) *In an effort to make the arts judging and participation more objective and less subjective in this process the following system is based on a Yes No Partial scoring system:*

Each “Yes” answer receives 1 point. Each “No” answer receives 0 points. Each “Partial” answer receives .5 points. You must leave a comment for any question that does not receive a “Yes” answer. A bonus point can be awarded in documentation, craftsmanship, and difficulty based on if the entry is above and beyond the normal scope of work.

Authenticity:

Yes or No

Does the entry represent an item that is authentic and within the scope of Lex Adria (Years from 793 to and including 1625; the Medieval and Renaissance cultures of Europe and those countries that had a significant presence in Europe during our defined period of history; arts, crafts and sciences that had an identifiable presence and influence in Europe). *If the answer is “No” to the

question then the piece will not be judged and will be removed from the lists with the written justification for removal.

Documentation:

Yes No Partial

Does the documentation provide at least one primary and two additional primary or secondary sources as well as cite the sources?

Does the documentation describe and validate the processes, techniques, and materials used to make the item?

Does the documentation explain and justify the changes and substitutions made in manufacturing or performance of the piece?

Point Breakdown:

- 1 out of 9 Points (with 1 point coming from Authenticity): Required for Participation

- 8 out of 9 Points (with 1 point coming from Authenticity): Knight's Tournament Win
- At least 10 Points (with 1 point coming from Authenticity): Masterwork

Authors Commentary: This may update other areas of the manual and the Imperial Arts Minister and Team along with the Chancellor will ensure that if this were to pass that all applicable areas would be updated to reflect the new judging format and style.

The concept behind the new system is due in part to many people stating that the arts system is extremely subjective and therefore discourages artisans from submitting entries due to harsh criticism or potentially unfair judging based on who judges the entry. By moving to a system that is based on an objective format it removes much of the potential of subjective judging. Our play test does show that a majority of judges and artisans found the new system to be more objective and faster to judge. Scores ended up mostly in line with masterworks being slightly harder to achieve overall.

NEW BUSINESS

NB1. Amend IEW#17 I.D. Minimum Ages.

All combatants under the age of 18 must have written parental/guardian approval. The minimum age requirements for combat participation in Adrian tournaments, wars or demonstrations are:

- a. Shinai: 12 years of age
- b. Rapier: 14 years of age
- c. Cut-and-thrust: 16 years of age
- d. Armored: 16 years of age
- e. Combat archery, shinai: 12 years of age
- f. Combat archery, rapier: 14 years of age
- g. Combat archery, cut-and-thrust: 16 years of age
- h. Combat archery, armored: 16 years of age

- i. Synthetic wasters (e.g., Rawlings): ~~16 years of age~~ 13 years of age

Authors commentary: In the Adrian Empire, the minimum age requirements for combat participation vary depending on the type of combat: Shinai (13 years old), Renaissance (16 years old), Armored (16 years old), and Combat Archery (13 years old). All combatants under 18 require written parental/guardian approval.

What this means is when we have a younger member who is 13 and has been fighting on the Sergeants list for his required eight participations and graduates to the Knights list he can no longer fight until they are 16. Categorically Shinai and wasters are considered the same. Only the armor requirements differ. I propose that we lower the age requirement to 13, allowing our younger members to continue to advance and train.

This will serve multiple purposes; keeping families, engaged and involved. Bringing in younger members that will eventually mature to lifelong members. The empire has always been about inclusion let's remedy this disparity. A minor would still require parental permission and could even have a separate waiver, if it is deemed necessary.

NB3: Change Armor Requirements for Cut and Thrust style combat:

Head

- a. A three-weapons fencing mask or a fully enclosed helm with fencing mask type mesh. Some fencing masks do not offer adequate throat protection. In this case, additional protection must be added. Masks with snap-in bibs are not sufficient and require neck protection as well.**
- b. The back of the head must be covered with semi-rigid material and cover the entire back of the head with no gaps Rigid protection is recommended.**
- c. The openings on the visor shall not be wider than 1/8 inch in any direction.**
- d. Metal helms require a minimum of 1/4 inch of padding and chinstraps.**
- e. 18-gauge lobster tail helms are recommended, but not required**

Neck

- a. A gorget of heavy or rigid material shall be used. Light leather or medium weight fabric with rigid plates attached is also sufficient (See Gorget in the Glossary).**
- b. A dog-collar style gorget alone is not sufficient.**

Body

- a. A minimum of 1/4 inch thick quilted gambeson, lined medium weight canvas or denim, or leather buff coat is required.**

Recommend Padded Fencing Jacket

- b. Kidney protection is recommended, but not required for combatants 18 years of age and older. Rigid kidney protection is required for combatants under the age of 18 years.**

Arms & Legs

- a. Rigid Elbow protection is required**
- b. Arms are to be covered by at least 1/4 padded material or equivalent.**

- c. Rigid Knee protection is required
- d. Semi Rigid Shin protection is required
- e. Semi Rigid Forearm protection is recommended

Hands

- a. Heavy Padded gloves that covers the hand and fingers is required
- b. Gloves must have finger and knuckle protection

Commentary: Cut and Thrust combat is an area in combat that does not get a lot of attention throughout the empire because of its current armor requirements with the advancement of HEMA and other fencing groups that are fighting with similar weapons to our current heavy rapiers they have shown that the different armor requirements can benefit our organization by promoting a better option to be able to cross play with other groups and get their interests involved into Adria as well.

The cost alone to fight C&T with the current armor standards could end up costing close to 2 to 3 thousand dollars whereas the new standards could easily get started in C&T for less than a thousand.
