Gabriele and Callon, by the Grace of God and Will of the Estates, Empress and Emperor of the Catholic and Sovereign Empire of Adria; Queen and King of Aleon, Navarre, and Pembroke; Duchess and Duke of Annelynerose, Brittany, Calais, Isle-de-Fleur, and Snowden; Baroness and Baron of Isenwold, Grenfeld, Hanover, and Lyon; Lady and Lord of the

Outlands and Islands; and Sovereigns of all Their Other Lands and Territories, to Their Patriarchs, Pontiffs, Archbishops, Bishops, and Clerics; Queens, Kings, Princesses, Princes, Duchesses and Dukes; Contessas, Earls, Vicereines, Viceroyes, Viscountesses and Viscounts; Champions, Doctors, Premiers, and Wardens; Justicars, Sheriffs, and Governors; Knights, Masters, and Ministers; and all Their faithful subjects:

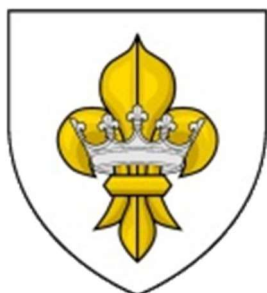
Greetings Dame Rhanwen MacDonald Grypernicus, Jarl Bjorn Ubbeson, Duke and Duchess of Chesapeake, Don Maren Pagano, Chesapeake's Heir Apparent, and Dame Tuathflaith ingen hui Chleirigh, Vicereine and Mayoress of the Canton of Weeping Rose,

Be it known to all to whom these presents come that We, Gabriele and Callon, Empress and Emperor of all Adria, do hereby grant this Imperial Land Use Agreement to the Duchy of Chesapeake. In accordance with the Lex Adria Imperium Article D.6.b, which gives the Imperial Crown the right to contract with the various chapters to allow said chapters to use Imperial Lands for chapter purposes, We do agree to the following:

We do hereby charge the Duchess and Duke of Chesapeake with this land for a term to expire no later than November ix, anno ludos xxxvij, being mmxxiv of the Common Era, or until the Charter of the Duchy of Chesapeake is officially amended by the Imperial Estates. We affirm unto them the following powers and responsibilities:

To report to Us on the State of the Imperial Lands in their care. To form cantons and appoint Ministers as needed, each of whom shall report to their corresponding Local Minister and through them, the Imperial Minister. To represent these Imperial Lands unto the Imperial Estates, as though they are their own for the term and length of this contract. To return these lands to the Imperial Crown at the end of this contract. To renegotiate this contract upon its expiration, should it be so desired by all parties concerned. All these conditions will be in accordance with Adrian Law & Custom.

We, according to Our Laws, do hereby fix the bounds of this Imperial Land Use agreement to be Franklin, Adams, Cumberland, Perry, Dauphin, Lebanon, Lancaster, York, Chester, and Delaware counties, of the mundane Commonwealth of Pennsylvania. It is also sworn, both on Our part, and on that of the Estates, that all the aforesaid shall be observed in good faith, and without any evil intention.
