Policy concerning Exotic Weapons

event sponsored by The Adrian Empire

It is the desire of The Imperial Crowns that new and innovative weapons be introduced to Adrian combat, while still maintaining that the weapon and style are as accurate a representation of medieval combat as we can do. We also feel that it is the duty and obligation of the Knights of the Order of Combat to be the leaders in this kind of development, We also believe that once proven to be safe these exotic weapons should be made available to qualified individuals oif the non-chivalry. Therefore we now Implement the following procedures for accomplishing this task:

1) After an exotic weapon has been used for a period of time not less then 6 (six) months, a member may petition the local

minister of Joust that it be removed from the exotic list. If, in the ministers opinion the weapon is safe enough for general use, he will issue a message to allow the weapons use in his area.

- 2) The local minister then MUST send this information to the Imperial minister of War and Joust for review. If the Imperial Minister of War and Joust will remove the weapon's exotic status for the empire, and make the necessary edits to the Imperial Combat Manual.
- 3) If a petition is declined, the member may repetition in another 6 (six) months.

Policy towards non Historical Weapons and Styles

It is the policy of the Imperial Crown that one of the missions of The Adrian Empire is to attempt to represent Medieval Combat to the best of our abilities. To do this we must walk a fine line between competition and exhibition. We believe we should encourage all combatants to try and use weapons that are period in natural, and to use them in manner that is consistent with their use during Our time period. We should discourage the use of weapons that did not exists during our stated time period, or the use of period weapons in a manner that is inconsistent with their use during our stated time period, in order to gain a competitive advantage on the field of combat. At this time we feel that these restrictions should not be applied to construction materials used so much as the actual weapon and how it is wielded. To help foster these policies We do hereby institute the following procedures for challenging a weapon, or the way in which it is used.

- 1) Any combatant may challenge a weapon on the field, or the style in which a weapon is being used.
- 2) Said challenge is to be made to the local Minister of War and Joust. Who must immediately inform the challenged party.

3) The

challenged party must cease using the weapon, or using the weapon in the style that was challenged, until such a time as he/she has provided documentation to the Minister of War and Joust justifying the challenged weapon or style. This documentation should be in the same form, and of the same quality as is required by the Arts and Sciences. This documentation is to be kept by the Minister of War and Joust, and a copy sent to the Imperial Minister in order to help populate a library of documentation.

- 4) All decisions of the local Minister of War and Joust may be appealed to the Imperial Minister of War and Joust.
- 5) Any Minister of War and Joust may deny a challenge if he/she feels it is frivolous in nature. This decision may be appealed to the Imperial Minister of War and Joust, and then to the Imperial Crown.
- 6) A weapon or style may only be challenged once.

With that business being finished, We wish to thank everyone who attended the Banner Wars, we had a great time out West., Congratulations go to York and Aragon for winning the Banners, and we look forward to seeing you both defend them next year!

Lastly, many of you will remember the apologies made last month by the Thrones of York. These were the result of a court order, of which we were the Justice. Upon reading the apology made by His Majesty Sir Killian, we found it not acceptable to the court. We informed His majesty of this fact, and that the Court found his apology not only to be insincere, but felt that it insulted this court and that He had in effect wasted our time. We then urged Him to publish a new apology. His majesty asked what would happen if He did not, and we informed him that the Court would have to find Him in contempt and place Him under Judicial ban until he complied. Sir Killian informed Us that in no way would he make another apology. We

suggested that he take a few days to think about it. During that time We received several calls from the Queen of York, Dame Jericho, as well as from the Chancellor of York Sir Trakx Greenwood, pleading His majesty case and begging that the court show mercy. It is because of the pleas of these 2 knights that We have decided not to hold King Killian under contempt, although We are still greatly displeased with his actions, and find them not only inconsistent with the Core Values of Adria, but an embarrassment to the Chivalry and Royal Peers. He will have to live knowing how We feel about him. The court will be taking no further official action in this case, and Sir Killian has his Queen and Chancellor to thank for this generosity.

Esperance

Unto the Populace of Esperance We do send Our Greetings!

First off, Banner War!!! Be it known to all that read this the mighty army of Esperance did acquit it self in grand fashion at the May Banner War held in deepest darkest Umbria. Mind you the army consisted of Ourself and Our trusty squire Terrin. The mighty army of Esperance did win a resounding 1/3rd of a War Point, but more importantly affected the outcome of the war by siding

with Aragon instead of those pesky Umbroids. Total score differential between Aragon (the Victor) and Umbria (the almost victor) was 1/6th War point.

We would also like to thank all of those We met at the banner war, and especially the graciousness of Our dear host, Queen Rowan and her wonderful populace who made every effort to assist Us in those strange lands.

We were shocked and dismayed to come back from Our wonderful excursion to said deepest darkest Umbria to find that one of Our knights had been injured at the Crossroads Renn Faire demo. We were even more upset to find that this had been caused due to an accidental overpowering of a newer member.

We did conduct a thorough investigation in the matter of injury at Crossroads Renn Faire We have come to the following conclusions:

- 1. Master Adrick was indeed qualified to participate in Light Renn Combat.
- 2. Master Adrick had been warned at least once that he was thrusting too hard during the same period of combat as the injury occurred.
- 3. Master Adrick did strike Sir Troianos with too much power, to the point where it did cause injury.
- 4. Master Adrick was using a diamond blade schlagger (not his own) that is much stiffer than a typical oval blade schlagger. We feel that this contributed greatly to the injury that occurred.

We will be enacting the following remedies by Royal Decree.

- 1. Diamond Blade Schlaggers are banned from use at events Sanctioned by the Crowns of Esperance. They are dangerous and have no place on Our fields of honor.
- 2. (a) Master Adrick of House Stone Cutter in the Canton of Aquataine has been placed under Ban the restricts him from fighting with metal weapons (includes but not limited to: Light Renn, Heavy Renn, and Heavy Steel Combats) for a period of One year and One day. (He may act as an archer, or standard bearer on the field so long as he does not use metal weapons).

Because Master Adrick has admitted that he accidentally did strike (thrust) Sir Troianos with far too much power than necessary we will include the following modification of his penance:

He may seek out a knight to train him in the proper use and how to be safe with these weapons. After a period of 30 (thirty) days he may petition the Royal Minister of Joust and War, Lord Gerhard Lagersuufer and Ourself. He must then satisfy Lord Gerhard and Ourself that he is indeed safe in the use of this weapon. Once he has been deemed safe, We will suspend the remainder of the sentence with regards to participation in combat.

2. (b) As additional penance, Master Adrick must present himself to Sir Troianos the Strong and deliver unto him 2 days of service. These are days when both Sir Troianos and Master Adrick are in attendance and at Sir Troianos discretion.

This is an example of an accident that could have been avoided. Sir Troianos did warn Master Adrick that his blows were too hard. Master Adrick, still being new to Light Renn combat, apparently did not have the experience necessary to control his power. While Master Adrick was still striking too hard, the excessively stiff blade compounded the force of the blow by failing to flex enough to absorb the blow.

It is never fun to have to mete out punishment. In coming to Our decision as to what would be appropriate We did take into account the seriousness of the incident as well as Adrick's age, experience and most importantly his Honesty in the matter. He has shown the great courage and honor that it takes to admit one has made a mistake. For this, We did show him the mercy We have. With proper guidance, he shall one day become a knight of great renown.

Cherry Claroutis

Served at Terre del Fuego Hunt dinner.

6 Servings

18 ounces fresh cherries, pitted, or one 16-oz bag frozen unsweetened pitted dark sweet cherries, thawed, drained.

1 tablespoon sugar

1 teaspoon cornstarch

1/3 cup all purpose flour

1/4 cup almonds (I double this quantity)

4 large eggs

Pinch of salt

1 cup milk

1/2 cup sugar

1/4 cup (1/2 stick) unsalted butter, melted

1 teaspoon grated lemon peel (or substitute lemon extract)

1 teaspoon vanilla extract

1/4 teaspoon almond extract

Powdered sugar

Preheat oven to 325 degrees. Generously butter shallow 1-1/2 quart baking dish. Combine cherries, 1 tablespoon sugar and cornstarch in medium bowl; toss to coat. Arrange cherries in bottom of prepared dish.

Blend flour and almonds in processor until nuts are finely chopped. Whisk eggs, salt and 1/2 cup sugar in large bowl to blend. Whisk in flour mixture. Add milk butter, lemon peel or extract, vanilla and almond extracts; whisk until smooth. Pour custard over cherries.

Bake clafoutis until set in cetner and golden and puffed on top, about 55 minutes. Cool slightly. Dust with powdered; serve warm if possible.

I doubled the recipe and baked the Clafoutis for about 1 hour and 15 minutes.


